





July 1, 2009 - December 31, 2009




Traverse Bay EDC


Traverse Bay EDC Regional Broadband Initiative Update—January 27, 2010

This document provides an update on activities and approach the Traverse Bay Economic Development Corporation is pursuing regarding high-speed internet availability across the four-county region, (Benzie, Grand Traverse, Leelanau and Kalkaska Counties). The objective and goal of this initiative is to develop and execute a broadband investment strategy at a regional level that clarifies the financial investment, infrastructure necessities, and economic benefit of high-speed internet availability across urban and rural sectors of the region.

The approach, which is segmented into three phases, is now ready to proceed onto Phase II. The Traverse Bay EDC plans to continue its engagement with Wireless 20/20, an independent consulting firm to assist in the development of the Regional Broadband Investment Strategy. Wireless 20/20 has completed studies in three of the four counties, and contributed to an American Recovery and Re-investment Act (ARRA) Round 1 application for Benzie County.

Phase 1

The purpose of Traverse Bay EDC's Phase 1 process was to conduct an inventory of broadband-related assets and high-speed internet availability in each individual county. This entailed identifying served, underserved, and un-served areas, along with physical assets, census tracks, existing providers servicing the county, stringent zoning, etc.



The study also presented financial investment models of wireless broadband network frequencies offered by wireless broadband providers currently providing, or targeting to provide, services within the county.

Each county funded their respective studies. Leelanau and Kalkaska counties contracted directly with Wireless 20/20 to conduct their respective studies. Grand Traverse County appointed the Traverse Bay EDC to perform their study in which they contracted with Wireless 20/20.

Benzie County contracted with Cherry Capital Connections, a wireless internet service provider,

to develop and submit an ARRA Round 1 application. As part of this activity, Cherry Capital Connections contracted with Aspen Wireless Networks who subcontracted with Wireless 20/20 to conduct an assessment of the service area and development of a wireless network investment model for the Benzie County application.

The Benzie County application may still be under consideration for award in the first round. The Benzie County Board of Commission did pass a resolution outlining their investment for an ARRA Round 1 application, which suggests that the County's Round 1 application/information be used/leveraged into a broader regional submission for an ARRA Round 2 application (ie, the Traverse Bay EDC's plans for Phase 2 activities.

All work for each of the other three counties has been completed with the results of each county study reported back to county stakeholders and the Traverse Bay EDC. The Traverse Bay EDC has reports on file for Grand Traverse, Leelanau, and Kalkaska counties.

Phase 2

The second phase of the initiative builds upon the previous work provided by each of the four counties. It utilizes their contribution as key data in the development of a Regional Broadband Investment Strategy. The Traverse Bay EDC will continue an engagement with Wireless 20/20 in the development of a strategy that will focus on the following three elements:

A Regional Broadband Investment Model

Each of the individual four-county WiROI™ models will be aggregated into a regional model that outlines a ten-year projection of revenue, capital expenditures, and operating expenses for a viable hybrid (fiber and wireless) network model.

Broadband Availability Business Case

Leveraging several sources (Phase 1 information, Economic Forecast, Grand Vision, service provider plans, community leaders, etc.) a business case that presents measurable economic benefits for broadband coverage at a township, county, and/or regional level will be created. It will outline practical actions that identified broadband providers within the private sector, and local units of government within the public sector, can cooperatively employ to achieve the economic benefit. Overall, this is a core component of the Regional Broadband Investment Strategy with an emphasis on:

- Economic Impact with 100% Broadband availability (Business / Residential)
- Capital Investment (Middle Mile / Last Mile)
- Township Zoning Impediments / Barriers

Regional Broadband Service Provider RFI/RFP (Middle Mile / Last Mile)

A Request for Information / Request for Proposal will be developed and delivered to identified Broadband Providers currently servicing and/or targeting service within the four county region. Through this process, service providers will be invited to participate and be included in the business case development through their specific contribution that supports broadband implementation in the four-county region.

A regional broadband investment committee having at least one (no more than three) representatives from each of the four counties and the Traverse Bay EDC will be established for Phase 2 and facilitated by Wireless 20/20.

Phase 3

The introduction of the American Recovery and Re-investment Act at the Federal level has driven regional action based upon the opportunity to apply for Federal grant funds targeted for Broadband expansion in rural underserved and un-served areas. The Notice of Funding Availability (NOFA) for round 2 has been published. The USDA Broadband Initiative Program has been structured for rural last-mile and supporting middle-mile applications. The BIP loan/grant submission timeline is from February 16th 2010 through March 15th 2010. Awards are targeted to be announced by September 30th, 2010.

As part of the Traverse Bay EDC initiative to expand broadband availability in the region, a specific emphasis of Phase 3 is to contribute and endorse a specific or set of broadband providers within the private sector in their application for ARRA Federal funding. Activities conducted and deliverables provided within Phase 2 will aid in their application. The goal is to ensure the broadband needs of the four counties are incorporated and the process is conducted in a coordinated effort with the applying service provider(s). This method will also allow regional constituents the ability to vet and validate their endorsement. The Traverse Bay EDC has no plans to directly submit an application for ARRA Federal funding. The setup and operation of a Broadband network falls outside the Traverse Bay EDC's charter for economic development services within the region. Due to the timing of the published NOFA for ARRA Round 2, activities in support of a service provider(s) application will begin in combination with the appropriate efforts conducted within Phase 2.

Other funding sources will be explored and considered for use as they become applicable. These may include, but are not limited to, Recovery Zone Bonds, Technical Assistance Grants, Community Development Block Grants, etc.

Phase 3 will also develop and employ a communication plan with local units of government that presents the Regional Broadband Investment strategy and the specific components of the Broadband Availability Business Case that have an impact in their local area. The goal is to educate townships and county officials on the possible social and economic prosperity in conjunction with current zoning that may be an impediment and/or barrier.



Fiber System IP Enhancements for Broadband Wireless

In recent weeks you have probably heard a lot regarding the lack of broadband wireless services in the Traverse City area and its negative impact on economic development opportunities for the area. This issue was a topic of discussion at the Traverse City Tomorrow forum last week.

Traverse City Light & Power was approached by Aspen Wireless and Mitten Communication who are proposing that Light & Power install IP enhancements to its existing fiber network to provide wireless communications to the community. Their proposed professional services agreement would include system engineering and project planning for application development in conjunction with the Traverse Bay Regional Broadband Initiative for TCL&P's submission for federal stimulus funding under available broadband stimulus programs. Applications for this final round of federal funding are due by March 15th which gives this a sense of urgency for interested communities.

Mr. Jim Selby and Mr. Robert Franzo will make a presentation regarding this opportunity for TCL&P at Tuesday's nights meeting. They have proposed implementation of broadband wireless in 3 phases for our entire community. Phase I will include application for the federal stimulus grant funds and the development of a comprehensive business plan to support proceeding with successive phases of the project. After several meetings with them in the past 1½ weeks I believe that this is an opportunity that merits your consideration. Based on the information I have learned, I fully support proceeding with Phase I implementation and recommend approval by the Board.

If after the presentation, discussion, and public comment the Board agrees with staff's recommendation the following motion would be appropriate:





Recent Michigan LED Grant to L&P

Grand Traverse County, in conjunction with Traverse City Light and Power and the City of Traverse City, applied for a received a \$250,000 Michigan Energy Efficiency Block Grant for the installation of Light Emitting Diode (LED) light in a variety of applications. The grant provides for the 80% of the purchase costs of the LED lights, with installation costs provided by TCLP as local match. The 20% purchase cost as TCLP match is estimated at \$97,000.

The Michigan Energy Efficiency Block Grant program is part of the American Reinvestment and Recovery Act (ARRA), otherwise known as the Federal Stimulus program.

Block Grant funds were received by the State of Michigan and distributed through the Michigan Public Service Commission. The MPSC issued a Request for Proposal throughout the State for two programs: Energy Efficiency Block Grants and LED Demonstration Grants. The State recently announced the award of \$17.4 million to 125 local units of government.

Grand Traverse County was also successful in receiving a \$353,575 Block Grant for lighting improvements and other energy efficiency measures at County and City facilities. TCLP is working with the County and City to assist in the implementation of the Energy Efficiency Block Grant, as well.

The LED Demonstration Grant will consist of three primary components:

- 1. Purchase and install LED lights for street lighting, outdoor lighting, and in buildings.
- 2. Data collection and research to detail the energy and cost savings of the installations and other project impacts; and
- 3. Outreach to the community to describe the project and explain the benefits.

The official start date has not been set, but the grant agreement is anticipated to be executed within the next two months with a one year timeframe to implement the project.

The initial step in the project will be to review, evaluate and select the type and manufacturer for each LED application, with a strong focus on Michigan suppliers.

An estimated 205 streetlights will be purchased and installed by TCLP staff, expanding the pilot LED project on West Front Street. An estimated 100 outdoor lights will be installed either by TCLP staff, depending upon the location, building staff or contractors, and an estimated 50 building lights will be installed by building staff or contractors.

Significant staff time from TCLP will be donated as in-kind and TCLP has committed to fund **20%** of the cost of the LED systems, as well as all labor and materials for installation, up to \$150,000 to match the EECBG grant.
