Stephen Cousins, Superintendant of Traverse City Area Public Schools (TCAPS), Majorie Rich, President of the Board of Education, Paul Soma, Chief Financial Officer and Director of Operations, and Rod Lowes, the Director of Energy, Environment, and Safety, will be attending this Board meeting to express their appreciation for the Energy Optimization funding for TCAPS energy efficiency projects.

The Light and Power incentive payment to the schools was \$8910. This was for the installation of 14 variable frequency drives (VFDs) which will result in a yearly savings of over 160,677 kilowatt hours of electricity. The VFDs allow a more energy efficient use of motors when coupled with heating, ventilating, and cooling units (HVACs).

At the Regular Board Meeting on July 27, 2010 the Board authorized the purchase of 200 LED overhead cobra head lighting fixtures. The total cost was \$126,400. The grant amount was for \$205,000. Staff recommends the purchase of another 125 fixtures at \$632.00 each for a total of \$78,600 to totally exercise the grant. This is the same price for the same fixture as previously approved. Wind Storm Report

This report addresses activities and events regarding the late October wind storm and how it affected Light & Power.

Light & Power sent a line crew to assist Cherryland Electric Cooperative in an effort to restore electric service to Cherryland's customers. Linemen Corey Schichtel and Kyle Mason reported early Friday morning (10/29/10) with a L&P bucket truck and worked late into the night and all day and night on Saturday.

It is common practice for utilities to send crews to areas of distress to assist in restoration efforts. In September 2005, a L&P crew was sent to Lafayette, Louisiana as part of a volunteer effort to restore electric service to southwest Louisiana communities hit by Hurricane Rita. In March 2007, a L&P crew was sent to assist Thumb Electric Cooperative to restore power to the residents of Ubly, MI and surrounding areas after a winter storm, and in February 2009 L&P sent two crews to Salem, Arkansas after an ice-storm devastated the area.

The L&P electric system was fully restored by 5:30 AM Thursday morning (10/28/10). Some intermittent outages occurred after that but power was readily restored.

Attached are pictures of downed wires and poles on the 138 kV International Transmission Company (ITC) transmission system near West Senior High School. The 138 kV transmission line links the Keystone Substation to the new Gray Road Substation. The pictures prove a point that we have been trying to make for some time now; the necessity and importance for a second main transmission line to support the Traverse City Light & Power electric system. The recent high winds knocked down at least 6 poles which were double circuited for service to the Gray Road Substation and Leelanau County. Normally power travels from Gray Road Substation to L&P's electric system but because these lines are down, power is traveling through L&P's Hall Street Substation to Gray Road and is helping to provide support to Leelanau County. If the Gray Road Substation had not been constructed, many more customers in Leelanau County would have been without power for a longer period of time.
