Staff has obtained sealed bids for the Bay Street underground conduit installation and site restoration project in the area east of Division Street and the Division Street crossing.

Base Bids were as follows:

Molon Excavating, Inc. \$539,590.67
J. Ranck Electric, Inc. \$788,702.10
Elmer's Crane and Dozer Inc. \$837,982.90
Corby Energy Services \$865,979.90
Advantage Electric No Bid
Alpine Electric No Bid
Rieth-Riley No Bid

Staff recommends entering into a construction agreement with low bidder Molon Excavating, Inc. in the amount of \$539,590.67 for the Bay Street underground conduit installation and site restoration project.

If the Board concurs, the following motion is recommended:

**RE: Bay Street Undergrounding Project** 

Dear Property Owner/Resident:

Traverse City Light & Power (L&P) along with its contractor is scheduled to begin work on the Bay Street Undergrounding Project in early May. The project will consist of converting the overhead electric facilities to underground on Bay Street, east of Division Street, to the Lighthouse Pole. There will also be additional work on Bay Street, west of Division Street, up to the Wayne Street intersection. The project will consist of two phases commencing with the installation of underground conduits, manholes and related facilities in May and June of this year. In the fall of 2011 the electric cables will be installed in the conduits followed by the removal of poles and overhead wires.

During the week of May 16-20 L&P will be laying conduit below the intersection of Division Street and the Grandview Parkway. In order to expedite the work on the intersection and keep disruptions to a minimum, work will occur between the hours of 6:00 p.m. and 6:00 a.m. Traffic delays and detours are to be expected on Bay Street, Division Street and the Grandview Parkway during this week. The Michigan Department of Environmental Quality (MDEQ) will be doing independent work on Division Street between Front Street and the Grandview Parkway during the same period of time.

Access down Bay Street will be limited or closed to through traffic during the course of the project. Appropriate signing and barricades will be in place to notify motorists and pedestrians of work being done.

On April 27 from 4:00 p.m. to 7:00 p.m. L&P will take part in an Information-Sharing Session with Michigan Department of Transportation and MDEQ at the Traverse City Area Chamber of Commerce. The purpose of the meeting will be to view plans and details for upcoming work planned on Division Street (see attached flyer). L&P will also be in attendance to review plans for the Bay Street Undergrounding Project. The public is invited to attend.

L&P is committed to keeping the inconvenience to you to a minimum and greatly appreciates your cooperation. Thank you in advance, and please feel free to contact me if you have any questions about the project.




- View plans for upcoming work planned on US-31/M-37 (Division Street) by the Michigan Department of Transportation (MDOT), Michigan Department of Environmental Quality (MDEQ) and Traverse City Light & Power (TCL&P). Agency representatives and MDOT's contractor (Elmer's Crane and Dozer) will be available to discuss this planned construction one-on-one with the public.
- Beginning mid-May, in advance of MDOT's project, independent work will begin on Division Street from Front Street to the Grandview Parkway in Traverse City. The work includes environmental cleanup near the intersection of Front Street (overseen by MDEQ) and underground utility work near the Bay Street intersection (overseen by TCL&P.) These projects are expected to be complete by the end of May.
- MDOT work begins in June with road construction on Division Street from north 14th Street to the Grandview Parkway. This project includes joint repairs, milling and resurfacing, concrete sidewalk/pedestrian ramp upgrades and crosswalk markings.
- MDOT work between Front Street and Grandview Parkway is scheduled for completion by the end of June. During June, surfacing will be performed at night, with Saturday work expected.
- No work will occur during July and August. MDOT work resumes after Labor Day, from south of Front Street to north of 14th Street, and is scheduled to be completed by early October.
- Two-way traffic will be maintained at all times with access to adjacent properties accommodated.
